On July 17, 2018, the world's largest bilateral agreement was signed between the EU and Japan. <sup>2</sup> It reduces or ends tariffs on most of the \$152 billion in goods traded. It will come into force in 2019 after ratification. The deal will hurt U.S. auto and agricultural exporters.
