### Coding Massage Therapy 97124 And

CPT Code 97124 - Massage Therapy: The AMA CPT (Current Procedural Terminology) 2013 edition describes 97124 as "Therapeutic Procedure, 1 or more areas, each 15 minutes; massage, including effleurage, petrissage and/or tapotement (stroking, compression, percussion).

### Coding Massage Therapy (97124) and Manual Therapy (97140)

CPT 97124 describes a service that is a separate and distinct service from Chiropractic Manual Therapy codes 98940-98943. CPT 97124 describes work including effleurage, petrissage, and/or tapotement (stroking, compression, percussion) and is based on each 15 minutes of treatment per unit.

### CPT code 97140 and 97124 - Massage Therapy and MANUAL THERAPY

CPT Code 97124 - Massage Therapy The AMA CPT (Current Procedural Terminology) 2013 edition describes 97124 as, "A Therapeutic Procedure, one or more areas, each 15 minutes; massage, including effleurage, petrissage and/or tapotement (stroking, compression, percussion)."

### Coding and Billing Massage Therapy (97124) and Manual ...

Description Code 97140 is used to report manual therapy ('hands-on') techniques that consist of, but are not limited to connective tissue massage, joint mobilization, manual traction, passive range of motion, soft tissue mobilization and manipulation, and therapeutic massage.

### CPT CODE 97010, 97124, 97140, 97012 - Massage Therapy ...

CPT Code 97124 Massage Therapy; CPT Codes 97110 Therapeutic Exercise; CPT Code 97112 Neuromuscular Re-education; Additionally, there are a lot of other similar CPT codes. Therefore, it is important to choose the right cpt code for massage therapy service that you provide.

The CPT codes massage therapists can use without question are: 97010 - hot and cold packs; 97124 - massage; and 97140 - manual therapy. In my opinion, any other code is questionable and should be avoided unless the user has certifications that have specified the CPT code that represents the procedure they are training you to use.

Additionally, do not use codes 97124 and 97140 to bill for massage work during the same session. The Correct Coding Initiative of Medicare has determined that there is not enough difference between these two codes to allow claim of their use in the same therapy session.

### Insurance Billing for the Massage Therapist | Massage ...

The AMA CPT (Current Procedural Terminology) 2019 edition describes 97124 as "Massage, including effleurage, petrissage, and/or tapotement (stroking, compression, percussion)". Massage is classified as a Therapeutic Procedure which is a time-based service.

### Massage Therapy (97124) - Health Network Solutions

Massage (CPT 97124) describes a service that is separate and distinct from those services described by chiropractic manipulative treatment and manual therapy techniques. Massage, unlike those techniques, is totally passive in nature, with no participation by the individual receiving the service.

### Billing for Massage - Specific CPT Codes

CPT Code 97124: "Therapeutic procedure, one or more areas, each 15 minutes; massage, including effleurage, petrissage and/or tapotement (stroking, compression, percussion)." Often insurance companies will deny the massage practitioner the use of 97140, stating that it is a "PT Code" (i.e. physical therapy) and therefore, not in "your scope of practice".

### CPT Codes Revealed - Massage Today

As per the American Medical Association (AMA), massage therapy (CPT 97124) includes kneading, wringing, skin rolling, rhythmic percussion, cupping, hacking, or plucking.

### What's the Different Between Manual Therapy and Massage ...

Covered billing code: Covered billing code CPT™ 97124 - used for all forms of massage therapy, regardless of the technique used. No other codes are reimbursed. Bill 1 unit of CPT™ 97124 for each 15 minutes of massage therapy.

### Physical, Occupational & Massage Therapy

Massage therapy provided by a licensed massage therapist is correctly coded as 97124 and is not covered by most carriers.
