The Supreme Court submitted proposed Federal Rules of Evidence to Congress on February 5, 1973, but Congress exercised its power under the Rules Enabling Act to suspend their implementation.

The House felt that rule 102, which directs the courts to construe the Rules of Evidence so as to promote growth and development, would permit sufficient flexibility to admit hearsay evidence in appropriate cases under various factual situations that might arise.

Rule 803. Exceptions to the Rule Against Hearsay | Federal ...

Under California law with respect to rebuttable presumptions affecting the burden of producing evidence, and under the federal rules with respect to all presumptions, unless the statute or rule creating them explicitly says otherwise, a presumption shifts the burden of going forward but not the burden of proof.
